CRIMES INVOLVING MORAL TURPITUDE

When an alien is convicted under a divisible statute INS must prove he was convicted under a subsection that is a CIMT If the subsection is not mentioned, then the benefit of the doubt will go to the alien In this case, the subsection was not listed and the court found no CIMT Hamdan v INS, 98

When do I need to replace my Permanent Resident Card? Apply to replace your Permanent Resident Card if any information on your card needs to be changed, or if your card has been lost, stolen, or damaged Also, if you became a permanent resident before you turned 14 years old, you are required to replace your card when you become 14 years old
